

## Preface

I have put this together simply to demonstrate a concept of idea on a method to document the undocumented immigrants in the United States. There have been so many references to millions, 11 million-20 million, who knows. The fact they are undocumented is proof we have really no clue as to how many there really are. First thing is first though. ANY person who wants to claim that they have even a small understanding of the term “illegal” basically it means not conforming to the law. So, we should agree that by not obeying the law, you are breaking it. Or in other words the law was broken. In any case, so we can try to get beyond this labeling issue and make an effort for these law-abiding citizens who only broke a specific law, to be able to Come Out Of The Shadows (COOTS) as they like to say. So, this is an opportunity to act like you mean it. Register, pay your fine and take your medicine. If you are a person who doesn't like to obey laws OTHER than the immigration law, then we should not be forced to allow you to remain here without worry. By spreading out the time frame to register keeps it from overloading the system. By having the forms available to be completed online, on an APP on the phones and at Libraries all over as well as other government agencies such as post offices and others. Having the process completed electronically expedites the process as well as the ability to compare and sort as well as search records more expeditiously. The funds collected will be a source of revenue for the federal government as well as the local community. Example of the \$2000 penalty charge at time of registration. It could be broken up something like \$100 each to go towards the hardware needed to be purchased to conduct the registration process. How many tablets can you get from 1000 applicants. \$100 per would offset the cost to pay the registering agents. \$500 goes to the local government where the registration is conducted. \$300 goes to the State and the other \$1000 goes to the Federal government to recoup funds set out for software creation, database implementation and dissemination and all the rest. I know when you are used to talking in Billions and Trillions it may still seem like small potatoes. But what is 10 Million time \$1000? 10 Billion! I know these politicians spend 10 billion for lunch as long as it's not theirs. But how about the other side benefit. Now these registered people cannot take jobs so others can get them and pay taxes on it. They cannot get any government (Federal) funds and who knows how much that is? Plus, once the border is secured and the criminal immigrants are out of our system then the country starts to save even more. So, for those who really are “Law abiding” and want to try to make moves to get right, it's a win for them. For the rest of the citizenry, it's a win for them. Of course, my dates, time limits, amounts, distribution are just points to consider. Play with the numbers and find what you believe works. How about increasing the penalty to \$2500 or \$3000? Then give \$500 from each one to the State where they register. That should incentivize California to get excited. Maybe you only want a 6-month grace period. I simply submit this for your consideration. Thank you for taking your valuable time to at least give it a look.

The purpose of this program is to get a handle on the numbers of undocumented immigrants in the United States. This will allow us the ability to document any person who entered the United States Illegally or has overstayed the time authorized by a Visa. Anyone who is not in the United States legally, who has committed any listed crime while they have been in the United States or if found to be guilty of any of the listed crimes in their home country, will be imprisoned or deported as determined by the courts. At time of registration, a fine of \$2000 (Two Thousand Dollars) will also be required to be paid to defer the cost of the programs implementation as well as penalties. Once registered the individuals will be allowed to report any crime they either observe or are a victim of without fear of deportation unless they have broken any law other than the Immigration Law which they are currently in violation of. The only eligible people for this form are those who have come to the United States Prior to 1/20/2017. The last date to be eligible to register and be protected from immediate deportation is one (1) year from the above date. After that time, anyone who is here illegally and not completed the registration form, will be subject to immediate deportation or incarceration as the courts determine. If an undocumented person becomes involved with any law enforcement personnel during this grace period will be required to complete the registration form prior to being released, provided the individuals involvement would allow for them to be released under the specified guidelines. By completing this form, the registrant understands that they will be allowed to remain in the United States without fear of deportation as long as they continue to obey our laws and their registration does not designate them for deportation or incarceration. They will be required to provide proof of Identity, residency, or employment. At the time of registration, they will further be required to provide Fingerprints, DNA sample and Photo to be used for ID card to be issued by the Federal Government. Upon satisfactory registration, the applicant shall be considered to be a "Registered Resident" which is not to be confused or mistaken as a "Legal Resident" Registered residents will not be authorized to work in the US legally, or eligible for Federal assistance and until such time they become a Legal resident, they cannot be considered for Citizenship. They would however be authorized to remain in the United States providing they will not become a burden on society. Whereas Legal residents have the right to work and become US citizens should there be satisfactory completion of a Citizenship application. Legal residents will remain entitled to benefits currently bestowed upon Legal residents providing there is no change to those qualifications or requirements.
